- Based on guiding principles given in Ind AS 108 "Operating Segments" the Company's business activity falls within a single operating segment namely, "Footwear and Related Products", hence, the disclosure requirements relating to "operating Segments" as per Ind AS 108 is not applicable.
- 4 The Board of Directors at its meeting held on May 23, 2023 have recommended final dividend at the rate of INR 0.25 per share i.e. 2.50% of face value of INR 10/- for the approval of shareholders for the year ended March 31, 2023.
- 5 During the quarter, 19,86,000 Equity Shares of face value of Rs. 10 per share were allotted to the warrent allottees.
